Contributors

Tore Rye Andersen is assistant professor at the Institute of Aesthetic Studies, Department of Contemporary Literature at Aarhus University (Denmark), and chief editor of the Danish literary journal *Passage*. He wrote his doctoral dissertation on the work of Thomas Pynchon, David Foster Wallace and Jonathan Franzen, and he has just finished a book on the contemporary American novel. His current research deals with the materiality and mediality of literature.

Francisco Collado-Rodriguez teaches contemporary American literature at the Universidad de Zaragoza (Spain). He has written papers on authors such as Kurt Vonnegut, E. L. Doctorow, Bharati Mukherjee, Jonathan Safran Foer, and Thomas Pynchon. In 2004 he published *El orden del caos: literatura, política y posthumanidad en la narrativa de Thomas Pynchon*.

William Day is a former professor of French and Spanish. He is the author of *Cruising with the Lowriders* (Ohio Northern University Monograph, 1982), resulting from an NEH Summer Seminar research project in East Los Angeles and Gordita Beach. He currently works in commercial and technical translation. He got hooked on Thomas Pynchon as an undergraduate when *V.* debuted.

Martin Paul Eve is a doctoral researcher and associate tutor at the University of Sussex (England) working on the interrelation between various schools of European philosophy and the novels of Thomas Pynchon. His work has been published in *Textual Practice* and *Rupkatha* and he has forthcoming articles on Pynchon, Don DeLillo, David Foster Wallace, Michel Foucault, and Ludwig Wittgenstein.

Robert Holton teaches literature at Carleton University in Ottawa, Canada. He has published articles on Pynchon previously in *Pynchon Notes*.

Zofia Kolbuszewska is associate professor in the Department of English at the Catholic University of Lublin (Poland). She teaches courses in literary theory and American Literature. In 2003/2004 she was a Fulbright Visiting Scholar at Columbia University. The author of two books, *The Poetics of Chronotope in the Novels of Thomas Pynchon* (2000) and *The Purloined Child: American Identity and Representations of Childhood in American Literature 1851-2000* (2007), and several articles on Pynchon, American postmodernism and American Gothic. She is currently working on a project concerning the sublime and the neobaroque in Thomas Pynchon's novels.

David Kelman is an assistant professor of English and Comparative Literature at California State University, Fullerton. He has published articles

Robert L. McLaughlin is professor of English at Illinois State University. He has published frequently on Pynchon and postmodern literature and culture and is the author, with Sally E. Parry, of *We'll Always Have the Movies: American Cinema during World War II* (Kentucky, 2006).

Sascha Pöhlmann is a lecturer in American Literary History at Ludwig-Maximilians-Universität Munich, Germany. He is the author of *Pynchon's Postnational Imagination* (Winter, 2010) and editor of *Against the Grain: Reading Pynchon's Counternarratives* (Rodopi, 2010).

Mark Quinn holds a PhD in English from University College Dublin where he taught in the School of English Drama and Film since 2005. After the publication of his first book, *The King of Spring*, the untold story of forgotten Irish Nationalist and Olympian Peter O'Connor (Liffey Press, 2004), Quinn returned to UCD to pursue a PhD on *Gravity's Rainbow*. Current projects include a monograph investigating the metafictional dimension to *Gravity's Rainbow* and Pynchon's recourse to Dante and Homer when structuring his novel (forthcoming 2012). Another work nearing completion is *The Hitchhikers Guide to the Other Side*, a true-life story detailing the unsolved gangland murder of aspiring Irish-American actor Barry Cunnane in Chicago in 2003 (forthcoming 2012). Currently, he is working as a member of the team at theflyingbookclub.ie.

Paula Martín Salván is an associate professor of English at the University of Córdoba (Spain). Her research focuses on Modernist and Postmodernist fiction and she is currently engaged in a research project entitled "Community and Immunity in Contemporary Fictions in English."

Jeffrey Severs is assistant professor of English at the University of British Columbia. He is co-editor (with Christopher Leise) of *Pynchon's Against the Day: A Corrupted Pilgrim's Guide* (University of Delaware Press, 2011), and he has published essays and interviews on the writing of Philip Roth, Norman Mailer, and Barack Obama.

Terry Reilly is professor of English at the University of Alaska, where he teaches Shakespeare, Renaissance literature, and world literature. He has published articles on Pynchon previously in *Pynchon Notes*.

Birger Vanwesenbeeck is assistant professor of English at the State University of New York, Fredonia where he teaches courses in world literature
