**Friedrich Arich** received his M.A. from Cologne University in 1993, and is currently involved in the research program "Literary Theory and Theory of Communication" at the University of Konstanz. His PhD project is "The Reader-Observer: A Revision of Reader Response Criticism with Niklas Luhmann's Systems Theory and Thomas Pynchon's *Gravity's Rainbow*."

**Graham Benton** is a PhD candidate at Rutgers, The State University of New Jersey. He lives in northern California, where he teaches at The California State University at Hayward. In addition to writing on Pynchon, he has published articles on Charles Dickens and Paulo Freire.

**Hanjo Berressem** teaches American literature and culture at the University of Hannover. He is the author of *Pynchon's Poetics: Interfacing Theory and Text* (1993) and *Lines of Desire: Reading Gombrowicz's Fiction with Lacan* (1998). With Bernd Herzogenrath, he edited *Near Encounters: Festschrift for Richard Martin* (1995). His fields of research include poststructuralism, cultural studies and the relation between the hard and the soft sciences.

**Denis Crowley** is a graduate student at the University of Manchester, England, where he is writing his PhD dissertation on the relation between aesthetics and politics in Pynchon's novels.

**Richard Crownshaw** is currently a doctoral student at Sussex University, finishing his thesis on representations of the Holocaust in American culture. He also teaches at Goldsmiths College, University of London.

**Inger H. Dalsgaard** is Assistant Professor of American Studies in the Department of English, University of Aarhus, Denmark. A graduate of the University of Aarhus, where she received a Cand. Mag. degree in English and religious studies, she recently completed her doctoral thesis at King's College, University of London, titled "The Fabrication of America: Myths of Technology in American Literature and Culture." She has published articles and given scholarly papers on Mary Shelley's *Frankenstein*, Melville, Pynchon and other topics. Her research interests include technology and culture, Asian-American literature, Romanticism and modernism.

**Christophe Den Tandt** teaches English and American literature as well as literary theory at the Free University of Brussels. The author of *The Urban Sublime in American Literary Naturalism* (1998), he is currently doing research on postmodern fiction and popular culture.

**Bernard Duyfhuizen** is Associate Dean of Arts & Sciences at the University of Wisconsin–Eau Claire. He has published widely and often on Pynchon, and he is one of the co-editors of *Pynchon Notes*. He is currently completing a book on the reader and *Gravity's Rainbow*.

**Luc Herman** teaches American literature and literary theory at the University of Antwerp, Belgium. He is the author of *Concepts of Realism* (1996) and the co-editor of *(Dis)continuities: Essays on Paul de Man* (1989). He covers Pynchon criticism for the *Annotated Bibliography of English Studies* (ABES), and is currently writing a book on the American encyclopedic novel.

**Zofia Kolbuszewska** is a lecturer in American literature at the Catholic University of Lublin, Poland. She has published several articles on Pynchon, American postmodernism, and the English literature of nonsense. Her current research deals with the image of childhood in American literature.

**Deborah Madsen** is Professor of English at South Bank University, London. She has published extensively on the Pynchons, including *The Postmodernist Allegories of Thomas Pynchon* (1991). Her other books include *Rereading Allegory: A Narrative Approach to Genre* (1994), *Postmodernism, A Bibliography, 1926–1994* (1995), *Allegory in America* (1996) and *American Exceptionalism* (1998). She edited *Visions of America Since 1492* (1994) and *Beyond the Commonwealth: Expanding the Postcolonial Canon* (1999). Her current research focuses on postcolonialism and the multi-ethnic literatures of the United States.

**Fran Mason** is Lecturer in English and Cultural Studies at King Alfred's College, Winchester. As well as writing on contemporary fiction, he has published on television, cyborgs, and Los Angeles. His most recent publication is an article on the novels of Richard Calder, and he is currently writing a book on gangster movies.

**Brian McHale** is Eberly Family Distinguished Professor of American Literature at West Virginia University, and Co-editor of *Poetics Today*. The author of two books on postmodernist fiction, and of numerous articles on narratology and twentieth-century literature, he is currently completing a book on the postmodernist long poem.

**Laurent Milesi** teaches English and critical theory at Cardiff University. He has published widely on twentieth-century literature, especially Joyce and postmodernism, and is currently editing a collection of essays on Joyce and language for Cambridge UP. He is finishing a book on "Post-Effects: Literature, Theory and the Future Perfect," of which the essay in this collection will form a chapter.

**Joseph Tabbi** is the author of *Postmodern Sublime: Technology and American Writing from Mailer to Cyberpunk* (1995) and the editor, with Michael Wutz, of *Reading Matters: Narrative in the New Media Ecology* (1997). His current project is a book with the working title *American Autopoesis* that reads contemporary American fiction in the context of cognitive science.

**Steven Weisenburger** is Professor of English and Co-Director of the Program in American Culture at the University of Kentucky. Author of *A Gravity's Rainbow Companion* (1988) and *Fables of Subversion* (1995) as well as *Modern Medea* (1998), a history of the 1856 Margaret Garner slave case, he is now working on a book about white-supremacist violence and the 1898 Wilmington, NC, massacre.
